TERMS OF USE OF IPS QR CODE WEBPAGE -GENERATOR AND VALIDATOR-

I. SUBJECT OF TERMS OF USE

1. These Terms of Use regulate the manner in which the IPS QR code to be used in bills/invoices is technically prepared (hereinafter: Generator) and technically verified (hereinafter: Validator) in a special part of the NBS webpage (hereinafter: IPS QR code webpage), as well as other issues of relevance for the use of the IPS QR code webpage.

II. BASIC TERMS OF USE OF THE IPS QR CODE WEBPAGE

2. The IPS QR code webpage is intended for facilitating the technical aspect of preparing (generating) the IPS QR code used in bills/invoices of payees to initiate payment transactions for the payment of such bills/invoices (hereinafter: NBS IPS QR code) and enabling technical verification (validation) of the prepared IPS QR code, in accordance with the technical requirements specified in Annex 1 of the Decision which regulates general rules on instant credit transfers (hereinafter: Decision).

By using the IPS QR code webpage, you consent that these Terms of Use shall be applicable to you as a user technically preparing (generating) the NBS IPS QR code or technically verifying (validating) the prepared IPS QR code and you oblige yourself not to undertake or be involved in any activity contrary to the purpose of the IPS QR code webpage, and/or an activity which in any way hinders or limits its operation.

The IPS QR code webpage cannot be used for sending content or performing other actions which are illegal, offensive, malicious, rude, threatening, improper, or contrary to any regulation of the Republic of Serbia.

III. TECHNICAL PREPARATION (GENERATING) AND VERIFICATION (VALIDATION) OF THE IPS QR CODE

Technical preparation (generating) of the IPS QR code

3. Technical preparation (generating) of the IPS QR code in the Generator shall include technical preparation of the NBS IPS QR code by filling in the defined elements or via textual string.

If data are entered in accordance with the technical requirements specified in Annex I of the Decision, the user is shown the prepared (generated) NBS IPS QR code which they can download and if there are errors – the user will be shown a log of each detected error. The use of the Generator is voluntary and by entering the data in mandatory elements for the preparation (generation) of the NBS IPS QR code you confirm that these data are accurate and agree to voluntarily submit them and that the National Bank of Serbia (hereinafter: NBS) may process them exclusively for the purpose of technical preparation (generation) of the NBS IPS QR code in accordance with the technical requirements specified in Annex 1 of the Decision. The data you enter in the Generator shall not be kept or recorded at the NBS server.

Technical verification (validation) of the IPS QR code

4. Technical verification (validation) of the IPS QR code in the Validator includes technical verification of the already prepared IPS QR code by uploading a file which contains the IPS QR code in formats which are defined and shown on the IPS QR code webpage.

After technical verification (validation) of the uploaded IPS QR code, the user is shown the data on whether the IPS QR code complies with the technical requirements specified in Annex 1 of the Decision, or whether there are certain errors in the IPS QR code – in which case the user will be shown a log of each detected error.

Validator use is voluntary and by uploading the file which contains the IPS QR code you agree to voluntarily submit the data from the file to the NBS and that the NBS may process them exclusively for the purpose of technical verification (validation) of the IPS QR code in accordance with Annex 1 of the Decision. The processed data shall not be kept or recorded at the NBS server.

Recommendations for use of NBS IPS QR code generator

5. In order to better understand the errors which users can make during technical preparation (generation) of NBS IPS QR code, and/or which are shown after technical verification (validation) of the uploaded IPS QR code, the IPS QR code webpage contains recommendations for use of the NBS IPS QR code generator which provide more detailed explanations related to the technical preparation of the NBS IPS QR code and technical verification of the IPS QR.

IV. DATA PROTECTION

Personal data protection

6. The NBS shall not require that in generating the NBS IPS QR code or validating the IPS QR code you enter any personal data and such data shall not be separately recognised, kept, recorded at the NBS server or used in any other way by the NBS.

The NBS shall allow that you generate and/or validate the IPS QR code by using the data that you voluntarily chose to use, without assuming any obligation regarding those data, or any liability or duty regarding persons to whom such data apply.

If you enter personal data for the purpose of generating the NBS IPS QR code or verifying (validating) the IPS QR code in line with these Terms of Use and/or upload the file with the IPS QR code containing such data – the provisions of Section 3, paragraph 3 and Section 4, paragraph 3 of these Terms of Use shall apply to the processing of such data. If in generating the NBS IPS QR code or validating the IPS QR code you enter personal data, you shall be obliged and responsible to execute all obligations prescribed by the law on personal data protection, and especially to ensure that there is the consent of persons to whom such personal data apply or another legal basis for the use of such data, as well as to ensure the fulfilment of obligations regarding the exercise of rights of the person to whom such personal data apply and the provision of all necessary information to such person in accordance with the said law.

Exchange and processing of other data

7. When you visit the IPS QR code webpage, your Internet browser forwards to us the data such as: IP address, date and time of the request, content of the request (specific page), the transferred quantity of data and status of access (e.g. file transferred etc), type of browser/version/language, operating system and its user interface. These data are technically necessary in order for the IPS QR code webpage to be displayed and to secure stability and security of its usage.

V. DISCLAIMER

8. The NBS shall not be not responsible for the functioning of the prepared (generated) NBS IPS QR code nor for the functioning of the verified (validated) IPS QR code.

The NBS shall particularly not be responsible for any direct, indirect, consequential or other damage incurred as a consequence of use of the IPS QR code webpage in a manner which does not comply with these Terms of Use, nor for any other damage incurred as a consequence of use of the NBS IPS QR code generated in the Generator (e.g. due to inaccurate or incorrect entry of any data), or the damage incurred as a consequence of use of the IPS QR code validated in the Validator.

VI. FINAL PROVISIONS

9. These Terms of Use are made in Serbian.

The NBS may prepare and publish the text of these Terms of Use in a foreign language, but in case of any discrepancy between the original Serbian text and the translation, the Terms of Use in Serbian shall be exclusively applicable.

Amendments and additions

10. The NBS shall have the right to make amendments and/or additions to these Terms of Use at any time and such amendments may be applied without delay.

Entry into force

11. These Terms of Use shall enter into force on the day of their publishing on the IPS QR code webpage.
